

1. That the accommodation provided for each of the several class rooms are sufficient for the minimum number pupils taught there in and is properly ventilated and lighted.
2. That the latrine arrangements are adequate and maintained satisfactorily and also kept clean & maintain with the bleaching powder and phenoil.
3. That the supply of drinking water is wholesome and that in all other necessary aspects the sanitation is good.
4. Drinking water source should be chlorinated daily.
5. That the Building is maintained sustained repair.
6. Adequate fire precautionary measures should be provided.
7. Adequate Emergency Exit should be provided.
8. Rain water Harvest structure must be provided in the premises.
9. The water tanks (syntax /cement tank) in the campus should be kept clean by protecting it from mosquitoes, the wastages like plastic items, broken bottles, and unused tyres should be replaced immediately from the rain water. Check every time whether the rain water staged in the terrace.
10. In School campus display of sign boards of size 60x30cm (No Smoking area- smoking here is an offence) inside the institution.
11. In School campus no sale of tobacco in the radius of within 100 yards in the educational institutions.
12. Conditions to be followed as per R.No: 86684/EPI/S1/2020 dated 07.11.2020 (Instruction of the chief Secretary meeting regarding SOP of School reopening held on05.11.2020)
13. Proper cleaning and sanitization should done at the School premises frequently and it should be recorded in a register.
14. Hand Sanitizers should be available in each classroom.
15. The entire people in the School should be screened by IR Thermal scanner daily.
16. That essentials such as sanitizers, thermal scanner, disinfectants should available in the premises sufficiently.






